# New Business - 8:35 pm

Consideration of a Resolution Regarding ANC 2E's Request for FY Funding of WMATA and Need for Long-term Planning- 8:35 pm

Commissioner Mathews moved to adopt a proposed resolution regarding the matter. Chair Lohse seconded the motion, which was voted on and passed (VOTES: 7-0-0). The resolution reads as follows:

On December 14, 2023, the Washington Metropolitan Area Transit Authority ("WMATA") announced a proposed fiscal year 2025 budget. Due to an unprecedented \$750 million budget shortfall, WMATA is proposing dramatic service cuts. These proposed service cuts are so severe that even WMATA describes its own proposal as a "worst-case scenario for the region's economy, quality of life, and environment."

Included in its proposed service cuts are bus lines that serve as critical modes of transportation for residents of ANC 2E. Specifically, the proposal calls for the total elimination (without substitution) of the D2, D6, and the G2. Moreover, the 30 Series bus lines along Wisconsin Ave. would also be significantly reduced. In short, the proposal would virtually destroy bus service to and through Georgetown and Burleith. This would significantly increase automobile-use and strand those without such an option. This would have a particularly negative impact on Georgetown University and patients and visitors to Georgetown University Hospital. It would be a disaster.

This situation would be replicated across the city, with dozens of bus lines being eliminated or greatly slashed. This change, if carried out, would be literally unprecedented for a city the size of Washington, DC. "Worst-case scenario" is far too optimistic for what this would actually produce.

ANC2E applauds the Mayor and Councilmembers for proposing additional funding to help avert these cuts. Furthermore, ANC 2E encourages WMATA to work with DC along with Virginia and Maryland to identify equitable funding increases to ensure that these devastating service cuts do not come to fruition. Finally, ANC2E asks DC and WMATA to develop long-term solutions to address the underlying causes for these funding shortfalls.

# Alcoholic Beverage and Cannabis Board - 8:40 pm

Consideration of a Resolution Regarding Application by Billy Hicks for a New Retailer's Class "C" Restaurant License at 3277 M Street NW (ABRA-127289)- 8:40 pm

The owner presented his application and answered questions. Commissioner Lindner moved to adopt a proposed resolution regarding the matter. Commissioner Maysak seconded the motion, which was voted on and passed (VOTES: 6-0-1). The resolution reads as follows:

ANC 2E protests the application of Billy Hicks Georgetown LLC, Billy Hicks, for a Retailer's Class "C" license at 3277 M Street NW. ANC 2E protests this application based on the adverse impact on peace, order and quiet of the neighborhood. The ANC agrees to withdraw the protest if, and when a satisfactory settlement agreement is executed by the ANC and the applicant and presented to the Alcoholic Beverage and Cannabis Board for approval.

## <u>Public Space Committee – 8:50 pm</u>

Application Public Space Application by Douglas Development for the Installation of Two New Planters at 1023 31st Street NW (DDOT #439203) 8:50 pm

Commissioner Lindner moved to adopt a proposed resolution regarding the matter. Commissioner Lohse seconded the motion, which passed (7-0-0). The resolution reads as follows:

ANC 2E supports the application of Douglas Development to place 2 new planters at the Canal House Hotel 1023 31<sup>st</sup> Street. The planters will be placed against the hotel/building. Even though these planters are in public space, they will not project into the sidewalk and will not cause any disruption to pedestrian traffic.

ANC2E is happy that this project is moving forward.
