RE: New Georgetown Community Partnership (GCP) Co-Chair

Dear Mr. Green and Mr. Peterson,

On March 31st, 2025 ANC 2E held its regularly scheduled public meeting, which was properly noticed and attended by eight commissioners, constituting a quorum. At this meeting the Commission adopted the following resolution by a vote of (8-0-0) with regard to the above-referenced matter:

Georgetown University is a fundamental and wonderful part of our community. In 2012, the [Georgetown Community Partnership](#) (GCP) was formed as part of the University's city-approved Campus Plan. The GCP provides a forum for community collaboration regarding the University's master planning and neighborhood quality of life initiatives. Ron Lewis - previous ANC Chair, nearly 50-year Georgetown resident, and experienced attorney- was instrumental to the formation of the GCP. Ron did so in close partnership with the University's president emeritus, John DeGioia, among others.

The GCP is led by a Steering Committee and has representation from two ANCs, the university's executive offices, three citizen associations, student leadership, and hospital management. Under the University's Campus Plan, adopted by the District's Zoning Commission, ANC 2E appoints the community's co-chair of the GCP. Ron has served as the community's GCP co-chair since the GCP's formation. Ron's leadership has been stellar. The GCP is strong, vibrant, and well-positioned to continue its work. This month, Ron formally announced his resignation from the GCP. ANC 2E applauds Ron's work on the GCP and looks forward to formally celebrating his service.
